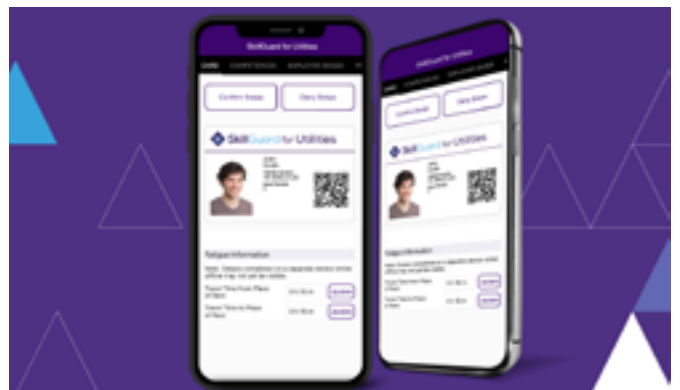
Comprehensive Records

Quality-assured EUSR registrations are automatically passed to SkillGuard for Utilities for any SkillGuard record holder whose EUSR number is recorded on the system.

EUSR develops schemes (or unregulated qualifications) – always in collaboration with employers and other key stakeholders – such as industry bodies and regulators – so the content, design and assessments meet employers’ needs.
